Subject: Disclosure of reasons for delay in submission of Unaudited Financial Results for the quarter and nine months ended 31st December, 2025.

Dear Sir,

With reference to your query received on the Listing Centre dated 5th March, 2026 regarding the non-disclosure of reasons for delay in submission of financial results for the period ended 31st December, 2025, we would like to submit the following clarification.

In accordance with Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, the Company is required to submit its Audited/Unaudited Financial Results to the Stock Exchange within forty-five days from the end of the quarter. Accordingly, for the quarter and nine months ended 31st December, 2025, the financial results are to be submitted on or before 14<sup>th</sup> February, 2026.

This is with reference to the Unaudited Financial Results for the quarter ended 30th September, 2025 and quarter ended 31st December, 2025, which have already been submitted by the Company to BSE Limited on 26th February, 2026.

We wish to inform you that while filing the said financial results, the Company inadvertently omitted to submit the explanation for the delay in filing the results within the prescribed timeline.

In this regard, we would like to state that the submission of the Unaudited Financial Results for the quarter ended 30th September, 2025 was delayed due to certain issues that had arisen earlier, the details of which had already been informed to the Exchange on 14<sup>th</sup> November, 2025.
